- Botulinum toxin, AKA "Botox," is a neurotoxin developed from clostridium botulinum, however the active molecule is a highly refined purified protein that does NOT contain bacteria
- The most frequently performed cosmetic procedure in the US
- FDA approved since 1989 for use in ophthalmic disorders (blepharospasm and strabismus)
- Granted FDA approval for the treatment of moderate to severe glabellar wrinkles in 2002

How does it work?

- "Dynamic" wrinkles are lines created by repetitive creasing or folding of the skin by underlying muscle contraction
- Injection into the muscle results in temporary relaxation of the contraction allowing for overlying skin to regenerate and recover
- There is a cumulative effect with regular use of Botox. Over time, more permanent weakness of the muscle can occur, leading to longer duration of effect between treatments!

Contraindications

- Pregnant or lactating women
- Hypersensitivity to any botulinum toxin A products
- Neurological disorders: ALS, myasthenia gravis, Lambert-Eaton syndrome
- Flu or cold symptoms, concurrent use of aminoglycoside antibiotics
- Skin infection involving treatment areas
- Pre-existing facial paralysis



May or may not occur, most often temporary and quickly resolving:

- Bruising, swelling, redness
- Weakness of muscles in un-intended area
- Double vision
- Headache
- Skin infection

Pre-Treatment Considerations

- Medication allergies
- Prior facial surgery
- Upcoming facials or treatments involving the face
- Use of alcohol or blood thinners within 24 hours of treatment

Treatment Locations

Customized to each individual, dosage and exact sites will vary

- Glabellar complex
 - Frown lines or "11's"
 - Procerus + Corrugator supercilli
- Frontalis
 - Forehead lines

Orbicularis oculi
"Crow's feet"



Post-Treatment Instructions

- Avoid lying down for 2 hours following treatment
- Avoid manipulation or heat to area for 3-4 hours following injection
- Avoid straining, vigorous activity, or heavy lifting for 3-4 hours following injection
- Avoid facials, peels, or microdermabrasion for several days following
- Avoid direct sunlight for 1-2 days

It may take 2-10 days to see full effects and last between 3-4 months. Follow up for enhancements should be schedule for 2 weeks
